NOTICE OF RATE INCREASE

The Fayette Water Supply Corporation ("FWSC") Board of Directors held a public meeting on August 15, 2022 and voted to increase the monthly base rate and water usage rates for water service for all members to be effective the October 2022 billing cycle.

This rate increase is felt necessary to accommodate the significant increase in demand for rural water due to historical growth in land sales and housing development that Fayette County is experiencing. To accommodate this development necessitates that FWSC expand their current infrastructure, including drilling a new well. This comes alongside the continued elevated costs for supplies and services to maintain the existing infrastructure.

The breakdown of this rate increase is explained below:
