## NOTICE OF RATE INCREASE

On May 19th, the Fayette Water Supply Corporation (“FWSC”) Board of Directors voted to implement another increase in the monthly rates for water services for all members. Expenses continue to exceed income due to inflationary increases, the costs of maintaining our aging infrastructure, the costs of compliance with state regulatory authorities, and the costs of ensuring a dependable supply of water to meet existing demands. While the previous rate increases authorized by the Board of Directors have helped offset some of the shortfall, FWSC must still do more to address the continuing shortfall for long-term sustainability purposes.

This decision has not been taken lightly, and the FWCS Board of Directors recognizes the difficulties that this new rate increase may have on your household. We believe it necessary, however, to ensure that we can continue to maintain and sustain the water resources upon which you rely.
